Public Engagement Summary



Background

This summer, we're improving road safety in the area of Cambridge Street.

For the last few years, community members have told us speeding and traffic volumes are a problem. We looked at traffic data and talked to residents to learn more. Then we developed a draft design to fix these problems.

The design included:

- Speed bumps to make cars go slower
- New curbs to narrow the road
- Rules about where cars can turn.

The plan is for these changes to be temporary. We would install more permanent measures when we finish a bigger study of traffic in the whole neighborhood.

Engagement

It was important to talk to people in the neighbourhod before building the draft design. In June 2025, we launched a project website which included traffic data, a video, and a map to explain the new design.

We put up an online survey asking residents how these changes might affect them. People could also call us or send emails with their thoughts. We got 325 people to fill out the survey.

Promotion

We promoted public engagement using:

- A project webpage –published June 23, 2025,
 1,497 views as of August 1, 2025
- Postcards –1,678 mailed the week of June 25,
 2025
- On-street signage –16 signs installed June 25, 2025

Who we heard from

Most survey respondents (nearly 89%) said they live in the project area. A smaller number drive through (4%), visit (1%), or work in the area (less than 1%). Several people also noted they both live and either work or drive through the area. The highest number of responses came from residents on Cambridge Street and Oxford Street, followed by Fleet Avenue, Warsaw Avenue, Dorchester Avenue, Lorette Avenue, Montrose Street, and Taylor Avenue.

What we heard

Residents are very concerned about traffic. The survey confirmed what we already knew. About three out of four Cambridge Street residents said they feel unsafe

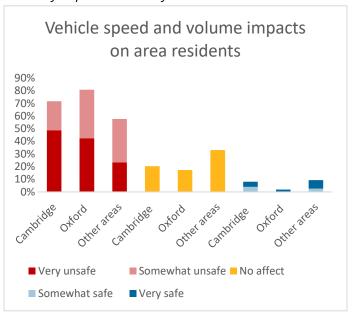

with current traffic conditions. Figure 1 shows these concerns extend beyond Cambridge Street.

Figure 1: Vehicle speed and volume impacts on area residents

Question: Do vehicle speeds and volume on your street currently impact how safe you feel?



Total responses: Cambridge Street n=74, Oxford Street n= 52, All other area residents n= 151

Survey respondents showed a strong understanding of the plan. In fact, 96 percent of people said they understood the design. Also, 66 percent of respondents believed it would improve quality of life on Cambridge Street.

However, with high levels of safety concern throughout the area, many respondents are worried that changes to Cambridge Street could push traffic problems to nearby streets.

Some asked for more traffic calming measures on their own streets. Many also asked for options other than what was presented. These alternatives included reduced speed limits, better traffic enforcement, or other road changes.

Overall, about one third of respondents support the plan, but many still have worries.

The project team carefully reviewed all comments to adjust the design as possible. A common request was to add speed humps to Oxford Street between Grosvenor Avenue and Corydon Avenue.

What we heard

How it was considered

Neighbourhood impacts

Changes on Cambridge Street will reroute

traffic: Concern that traffic changes meant to calm Cambridge Street will push more vehicles and dangerous driving onto nearby residential streets with no traffic calming. Some residents asked for more traffic calming measures on their blocks or area traffic planning.

Survey quote: "This will force more traffic onto neighbouring streets ... which already sees an unhealthy amount of through/commuter traffic at unsafe speeds."

Speed bumps and traffic-calming curbs mainly slow down cars. We only expect small changes in the number of cars using these streets. We will count traffic on Cambridge Street and nearby streets to see if the number of cars has changed, and we will share this information with Council along with a long-term traffic management plan.

Based on feedback, the speed bumps planned for Oxford Street will now extend one block south (from Grosvenor Avenue to Corydon Avenue).

Use of back lanes to avoid street calming: Back lanes near Cambridge Street are already used to by-pass existing calming measures and worry this will increase.

Survey quote: "The back lane needs speed humps as well. I am worried it will be used as an alternate route. It currently is used during the no left turn off of academy"

How it was considered

We are not making any changes to the current back lane rules. We will continue to allow left turns into back lanes because this helps residents who live in the area get home more easily. The first block south of Academy Road is long, and back lanes naturally support slower speeds, so we don't expect major problems. We will monitor concerns submitted to 311.

Lower speed limits before physical

changes: Reducing the speed limit to 30 or 40 km/h with proper enforcement would be a cheaper and more consistent solution than adding speed bumps.

Survey quote: "This neighborhood should have speed limit of 30 or 40. A speed limit of 50 is way too fast for this area snd (sic) I fear for my kids safety when playing in the front yards and chasing a ball onto the street. Reduce the speed limit!"

Recommendations of the Reduced-Speed Neighbourhood Pilot could apply across Winnipeg. We expect to present Council a report with recommendations later this year. That said, changing the speed limit alone has limited effect. It should be combined with physical changes, such as speed bumps, to successfully lower speeds.

Improve enforcement of speed limits:

The comments suggest that instead of adding new traffic calming measures like bumps or circles, the city should focus on better enforcement of existing speed limits. Both commenters believe that ticketing speeders and using cameras would be more effective and fair than making roads uncomfortable for everyone.

Survey quote: "Lower the speed limit and have more police presentence during rush hours."

Navigation of new traffic calming curbs

Enforcement is done with Winnipeg Police Service and depends on their availability and priorities.

We will place traffic calming curbs near intersections and pedestrian crossings where parking is usually not allowed. Some parking spots will be lost, but there is still enough parking space available on the street. Diagrams of the curb locations can be found

Use of speed humps	
Speed humps are disruptive and/or not effective: Some residents feel speed bumps are ineffective, especially for larger vehicles, and can be harmful or hard to see. Survey quote: "Often speed bumps are too pronounced and often not well-maintained."	Speed humps slow speeds by causing a vehicle to move upward and create discomfort for those traveling at higher speeds. All speed humps will be signed and have pavement markings for clear visibility.
Existing speed humps are old and ineffective: Some resident noticed that the existing speed humps have deteriorated.	All of the existing speed humps in the area will be checked. They will be replaced if they no longer meet the proper standards.
Submission quote: "The current speed bumps have flattened out since they were first installed more than 20 years ago and are now completely ineffective in reducing speeds on this section of roadway."

Next steps

Based on the feedback we received, the speed bumps planned for Oxford Street will now extend one block south (from Grosvenor Avenue to Corydon Avenue). We will check all current speed humps in the area and replace them when required.

Construction on this interim solution will start in August 2025. This will help slow down cars and make the roads safer for everyone until we can do a bigger traffic study for the whole neighborhood.

We will count how many cars use Cambridge Street and nearby streets to see if the numbers have changed, and we will share this information with City Council.

Residents can call 311 right away if they encounter any issues.

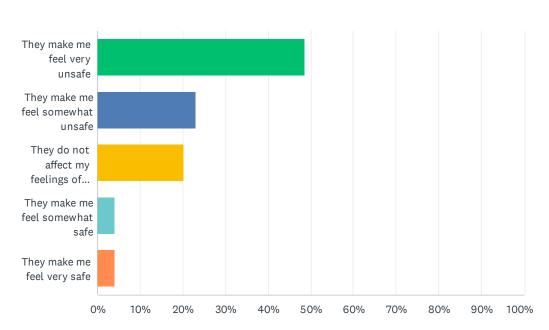

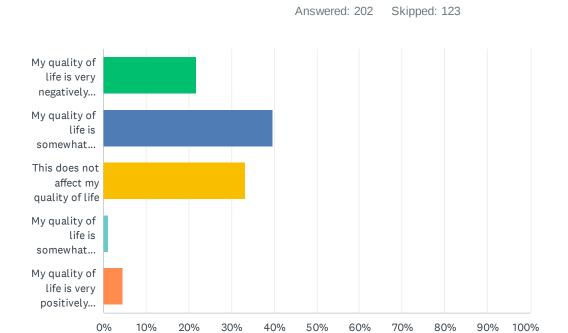
Q5 Do current vehicle speeds and volume on Cambridge Street impact how safe you feel?

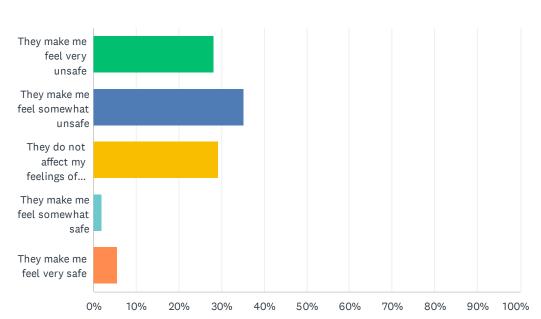
Q6 Does the speed and number of vehicles on your street currently impact your quality of life?

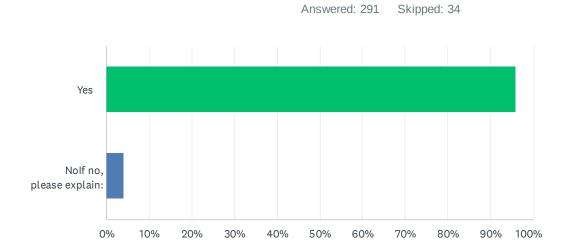
Q7 Do vehicle speeds and volume on your street currently impact how safe you feel?

218	I do not believe speed is the issue on Cambridge Street. It's nearly impossible to even get up to the speed limit because of the need to constantly doge oncoming traffic north of Corydon. Better traffic control may be necessary at the intersections with Fleet and with Grosvenor or Kingsway. The issue of narrow streets is exacerbated in the winter when people park even further off the curb. Every day, there is at least one or two large vehicles parked significantly off of the curb blocking traffic and they never seem to be ticketed or move. The only time I've personally seen vehicles moving fast is when the need arises to "shoot the gap" and leapfrog parked cars in gaps with oncoming traffic. Seeing as there is no visible speed limit posted between Academy and Grant, one must presume it's 50 km/h and as I said previously, it is nearly impossible to reach that speed north of Corydon and not something I have witnessed south, either. 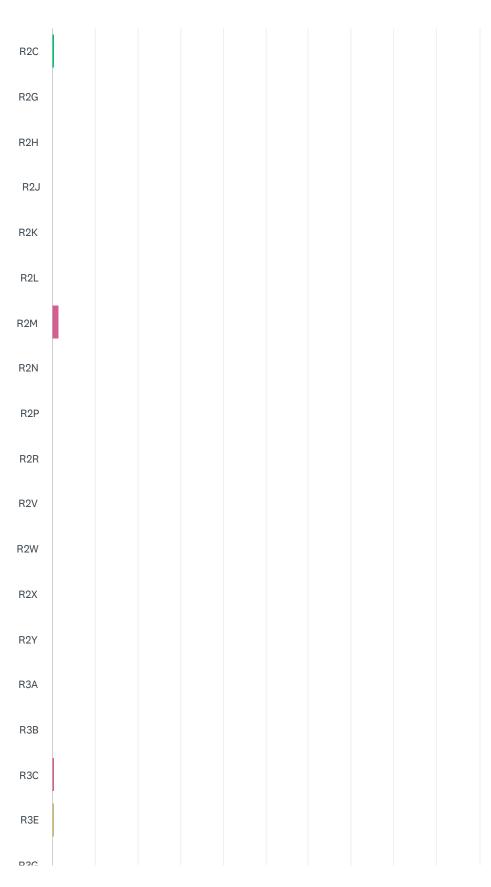

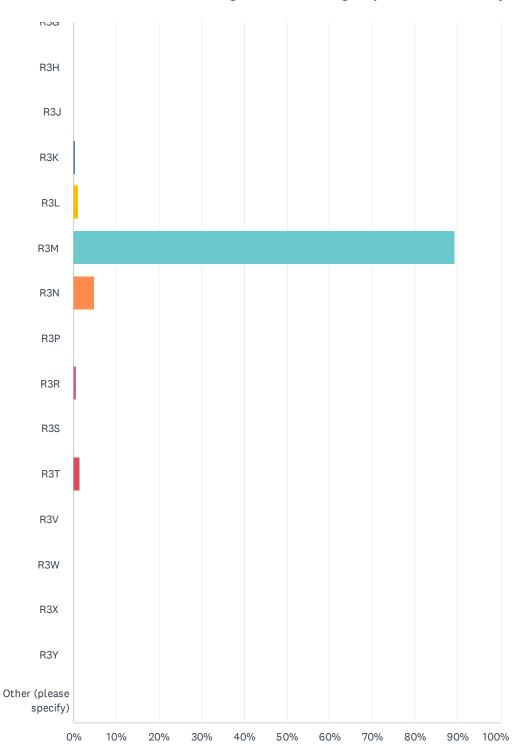
