INSECTS CONTROLLED: Aphids, mealybugs, spider mites, whitefly, soft brown scale, psyllids, rose or pear slugs and earwigs on houseplants, vegetables, fruits, shrubs, trees or greenhouse plantings.

DIRECTIONS FOR USE: Mix fresh solution. Made of selected soaps that have contact insecticidal properties. Insects must be sprayed directly to achieve proper control. Mix one part concentrate to 50 parts water, or 10 mL per 500 mL. For aphids, mealybugs, spider mites and whitefly, apply weekly for 2-3 weeks and thereafter repeat as required. For other insects, apply when they occur and repeat as needed.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Concentrated soap may cause eye irritation. Avoid eye contact. May cause skin irritation. Do not use on sweet peas, nasturtiums or delicate ferns. Wash fruits and vegetables before using.

DISPOSAL: Do not reuse empty container. Wrap empty container and discard in household garbage.

FIRST AID: If in eyes, Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically. The active ingredients in this pesticide are specially selected soaps. No other pesticides are added.
