AND WHEREAS the Charleswood-Tuxedo-Westwood Ward Councillor's office has received many concerns regarding speed, noise, drivers not adhering to stop signs, and other forms of dangerous driving on Laxdal Road;

AND WHEREAS residents on Laxdal Road have front driveways and the increase in traffic has increased the risk for accidents:
