#### **Background**

The Winnipeg Fire Paramedic Service (WFPS) preserves the safety, quality of life, and the property of the residents, and visitors to, the city of Winnipeg.

We are a unified response agency, providing services in the following areas:

- Fire and rescue operations
- Medical response
- Fire and injury prevention
- Emergency preparedness and response



#### **WFPS Strategic Direction**

In 2020, we published a <u>comprehensive strategic plan</u> to prepare the department to appropriately meet current and future needs.

The plan takes into consideration three reports: the <u>WFPS</u> <u>Master Plan</u>, the <u>Community Risk Assessment Standards</u> <u>of Cover</u>, and findings in the <u>Fire Underwriters Survey</u>.

The recommendations provided in these reports address serious infrastructure and operating capacity deficits that threaten the ability of the department to fulfill its response and regulatory mandates.



#### **Key report findings**

- Some WFPS stations are not ideally located and some have overlapping coverage areas.
- Many WFPS stations need total replacement or significant renovations.
- The department can reduce the number of stations from 30 to 24 and still provide timely emergency response.
- A station in Waverley West is needed.



#### **Current situation in Waverley West:**

Emergency resources are dispatched from:

Station 22 (1567 Waverley Street)

Station 23 (880 Dalhousie Drive)


Station 12 (1780 Taylor Avenue)

### **Future situation in Waverley West:**

Temporary Station: 110 Eaglewood Drive

Permanent Station: planned for 2025





#### Planned next steps:

- Ongoing Consolidation of Stations 9 & 15 into a new Windsor Park Station (Construction slated to start in Spring 2023)
- November 2022 Temporary zoning variance for land for temporary station
- Temporary, prebuilt station will be placed in Waverley West
- Fire engine from Station 15 will be moved to Waverley West
- Construction of a new, permanent fire-paramedic station will begin based upon budget approvals by Council.



#### **Temporary Station: Key Milestones**

- Temporary zoning variance appeal process
- Request for Proposal
- Tender award
- Site preparation
- Placement and final details



#### Impacts of temporary station

- Temporary station would occupy one acre of green space on Eaglewood Drive.
- Some potential noise and minor traffic impacts during site preparation which is expected to take two months.
- Once occupied, residents will hear sirens when crews are travelling to emergency calls (not all calls)

### **Zoning Variance Approval Process**


You can submit a zoning appeal until November 28, 2022 at 4:30 p.m.

#### **Proposed Location of temporary station**



### **Permanent Waverley West Station**


- Project is aligned with the land-use planning process for the South Winnipeg Recreation Campus project.
