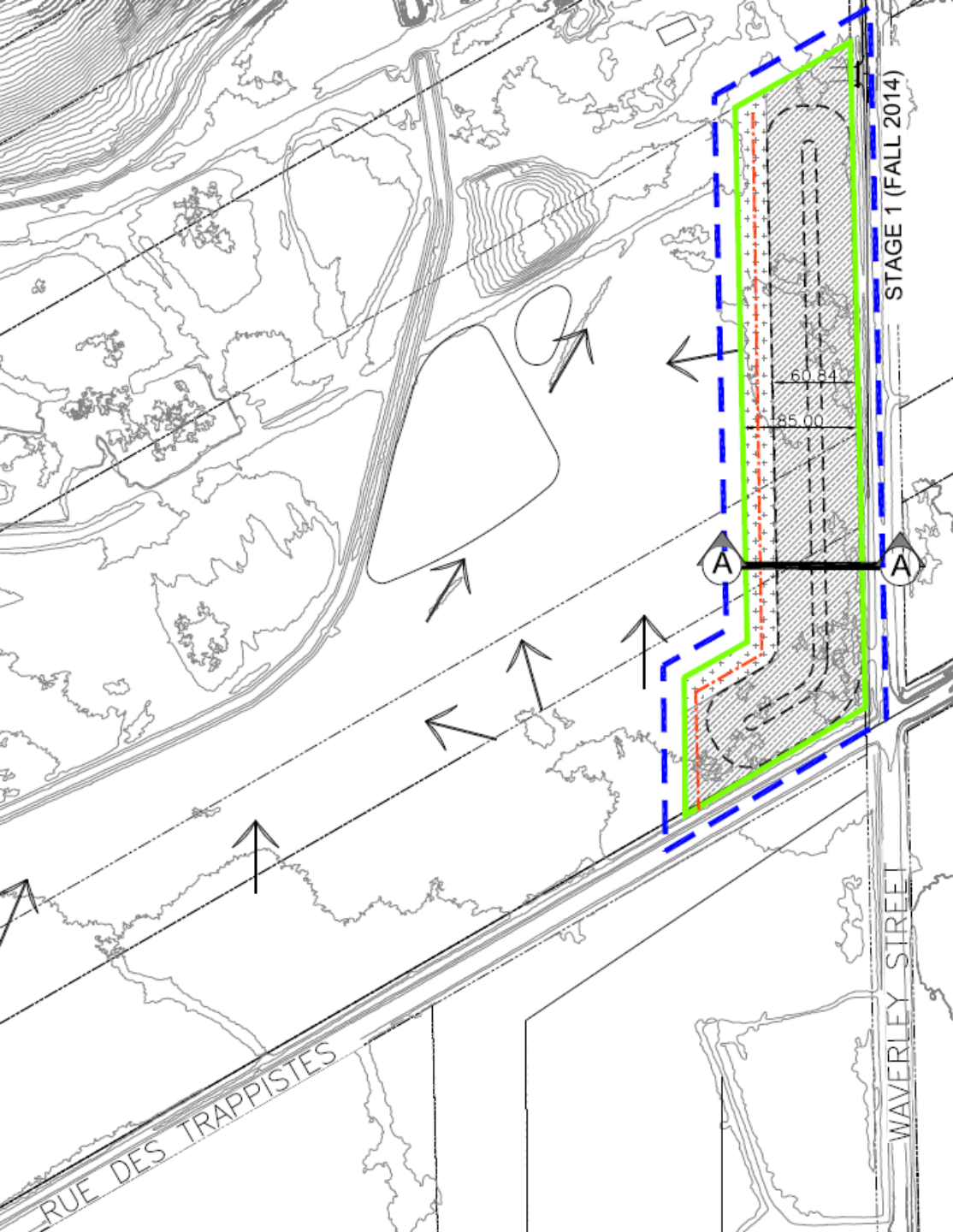

Short-term Landscaping Plan/ Lime Mud Berm Construction Updates

- Phase 1 berm:
 - original plan almost complete
 - may construct higher and wider than originally proposed to provide a better buffer (20 feet high by 200 feet wide)
 - changes to truck route
- Phase 2 berm:
 - construction targeted to begin early 2015
 - will have north-facing focus along Brady Road at the Perimeter Highway
 - will replace formerly proposed south-facing berm

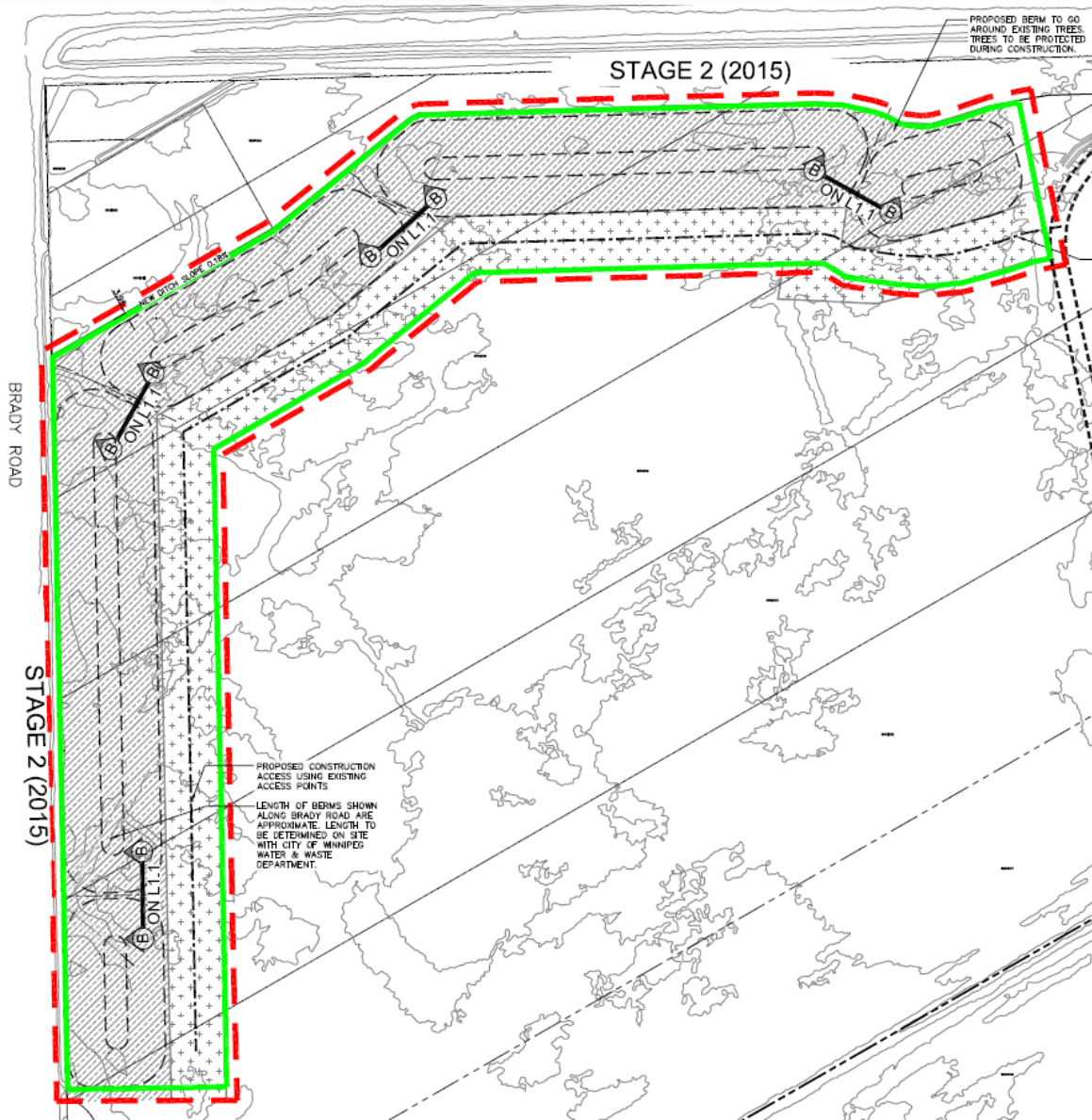


Phase 1 Berm

- Brady Road at Perimeter Highway



Seasonal/Project Updates

- New pilot biosolids composting complex
 - to be fully operational in early 2015
 - will compost about 20% of the biosolids produced
 - will produce over 300 cubic metres of compost per week, to be used as a final cover on the landfill to enhance vegetation growth
- Annual monitoring report
 - report on all ground water, surface water, and methane gas sampling done at Brady in 2014
 - due April 23, 2015

Seasonal/Project Updates (cont'd)

- Organics diversion strategy
 - issued request for proposals
 - will identify opportunities to divert organic material from the landfill (e.g., kitchen waste, biosolids, animal waste)
 - report to Council expected in late 2015 or early 2016
- 4R Winnipeg Depot construction
 - depot design is complete and construction will begin in spring 2015
 - work continues with Producer Responsibility Organizations to confirm materials that can be accepted

Odour, Noise, and Nuisance Concerns and Updates

- Falcon Environmental Services
 - new falconer starting April 2015
 - one-year contract, with three one-year extensions
- Other concerns

Leachate and Surface Water Management Concerns and Updates

- New leachate hauling contractor starting April 2015
 - three-year contract
 - annual savings \$200,000
- Other concerns

Access Management and User Experience

- Traffic issues
 - Province working on redesign of highway 330
- Working on new signage at Brady

Research Partnerships and Resource Development

- Continuing to explore options to use resources at Brady for energy (e.g., landfill gas, wood burning)
- Currently reviewing proposals

Long-term Site Planning

- Cell phasing
 - cell 1:
 - first half is complete and accepting commercial waste since December 2014
 - second half will be completed in early 2015
 - cell 2:
 - is being designed
 - will be constructed 2016
 - will be south of cell 1
- Landfill disposition study
 - request for proposals put out to explore options for Winnipeg's 33 closed landfill sites

Long-term Site Planning (cont'd)

- Energy East Pipeline update

Waste Diversion Advisory Committee

- The committee will be established:
 - as one of the recommendations in Council-approved Garbage and Recycling Master Plan
 - in 2015
- Role of the committee is to provide:
 - advice for the completion, implementation, and continual improvement of the Garbage and Recycling Master Plan
 - input into the development of the Organics Diversion Strategy
